(New Submission RWJF): Advancing Health Equity and Social Justice in Public Health Research, Education, Practice, and Policy

Project Narrative: Temple University's College of Public Health is leading a new movement to reimagine the future of public health. Through diversity, equity and inclusion initiatives, transdisciplinary research, and interprofessional education, our faculty and students embrace public health as a catalyst for individual and community change and well-being. We understand that diversity is expressed in myriad forms, including—but not limited to—race and ethnicity, gender identity, sexual orientation, socioeconomic status, language, culture, national origin, religious commitments, age, disability status and political perspectives. We also understand that structural factors including racism and discrimination and biases and white supremacy create unfair obstacles in academia that limit support and advancement opportunities. We recognize that there are critical barriers to building capacity to recruit and retain diverse faculty; obstacles that prevent institutions from supporting underrepresented scholars to succeed in areas of research, grants and publications, and community engagement; and limited efforts to advance and support the progression of junior faculty. We are *committed* to working with the Coordinating Center to: 1) assess historical and institutional context, structures, the adaptive challenges, and processes to lay the groundwork for a shared DEI vision. 2) recruit. retain and promote a diverse and inclusive faculty and organizational leadership, 3) improve inclusivity by incorporating diversity and inclusion in significant ways in training, practice, teaching, and research, and 4) build upon existing partnerships and create new partnerships that enhance the organization's commitment to and work with diverse populations to achieve health equity. This plan is intended to meaningfully expand DEI engagement in research, teaching and service and raise awareness of purposeful community-partnership engagement as a college priority. Role: Principal Investigator/Project Director

(Resubmission of a scored NIH R01 Grant): *Yo me Vacuno*: A culturally congruent community multi-level intervention to address COVID-19 health disparities among Latinos Project Narrative: The proposed study is highly significant because it targets Latinos, a vulnerable population disproportionately impacted by COVID-19, and builds from effective Popular Opinion Leader (POL) intervention approaches. MPIs Wu, Martinez, and Carlos-Rodriguez will partner with a robust network of Federally Qualified Health Centers (FQHCs) in Indianapolis, IN, Philadelphia, PA, and San Juan, PR to test the effectiveness of *Yo Me Vacuno*, a multi-level evidence-based intervention that includes comprehensive capacity building for FQHC staff on COVID-19 disparities, promotores/peer-led approaches, social-media outreach, and a hotline in English and Spanish with up-to-date information about COVID-19. The project is innovative in that it targets multiple points in the COVID-19 response; is responsive to the goals of National Strategy for the COVID-19 Response and Pandemic Preparedness; leverages strong partnership between research team, FQHCs, and local health departments and state officials; and will serve to expand and scale up COVID-19 vaccination efforts and vaccine delivery models

Role: Co-Principal Investigator

(New Submission NIH R34): Development and feasibility testing of a digital health intervention to reduce internalized HIV Stigmas and optimize HIV Care Continuum outcomes for South African adolescents MSM

Project Narrative: South Africa has the highest number of people living with HIV in the world. The proposed study is highly significant because it engages a vulnerable population, South African adolescent males who have sex with other males and are living with HIV, and builds from formative and developmental work with sexual and gender minorities in low- and middleincome countries. The study will advance HIV science by developing and evaluating the feasibility, acceptability, and practicality of a digital behavioral intervention designed to reduce HIV-related internalized stigmas and subsequently increase engagement, retention in care, and ART adherence among South African adolescent males who have sex with other males. Role: Contact Principal Investigator

(New Submission NIH R01): Assessing the Impact of Employment Laws and Policies on Health Disparities and Inequities

Project Narrative: The proposed study is highly significant because it aims to assess how existing employment policies impact health, ultimately promoting the development of more inclusive and health-promoting policies and builds from research team's expertise in legal epidemiology, mixed-methods studies, and health disparities and inequities research. Through rigorous quasi-experimental, quantitative and qualitative methods, we will evaluate the effects of employment laws and policies on mental health outcomes among low-wage workers. Pursuing multi-sectoral, multi-level, and multi-outcome research will strengthen and advance the existing evidence base on whether particular employment policies can help to address health disparities and inequities.

(New Submission NIH R34): Acceptability and Feasibility of Biomarker-based Adherence Testing and Align-Brainstorm-Commit for PrEP Medication Adherence and Retention in Care Project Narrative: Daily pre-exposure prophylaxis (PrEP) is highly effective at preventing new HIV infections; however suboptimal adherence and persistence, despite elevated risk, undermine its utility. Objective adherence testing (OAT) coupled with Align-Brainstorm-Commit (ABC) could enhance PrEP adherence by rapidly assessing recent adherence to tenofovirbased PrEP and providing culturally and linguistically appropriate client-centered sameday adherence counseling to patients. Results from the current feasibility and acceptability study may have a significant impact by informing clinical guidance to effectively scale up PrEP adherence support for communities disproportionately impacted by HIV. Role: Co-Principal Investigator

(Scored CDC U01 Grant): Transhealth Information Project: A Peer-led HIV Prevention Intervention to Promote HIV Protection for Transgender Women.

Project Narrative: We will strengthen the CDC funded Transhealth Information Project (TIP), a hybrid individual and group-level peer-led intervention to reduce sexual risk among transgender women (TW), by testing its efficacy in a randomized control trial. If efficacious, the intervention can then be replicated in various communities to provide support and facilitate behavior change for at-risk TW. This project will generate intervention content and clearly defined protocols that can be easily replicated within communities and by providers who do not operate in a research capacity.

Role: Principal Investigator

(Scored NIH R43 Grant): Developing a Social Media Intervention to Increase HIV Testing and Linkage to Care for Latino Adolescent MSM and Latina MTF Transgender Adolescents.

Project Narrative: This study involves conducting formative research to develop a culturally appropriate social media intervention to increase HIV testing and linkage to appropriate HIV care for predominantly Spanish-speaking Latino Adolescent MSM and Latina MTF Transgender Adolescents. The intervention draws upon the principles of the information-motivation-behavioral (IMB) model. The formative research includes a cross-sectional survey, focus groups, usability testing, and in-depth interviews.

Role: Co-Principal Investigator

(Scored CDC Grant): Multidisciplinary Capacity Building Assistance for the HIV Prevention Workforce: A Collaborative Approach to Improve HIV Outcomes in the Northeast Region through Multimodal Technical Assistance

Project Narrative: Our multidisciplinary team will use tailored technological supports and interpersonal dialogue to implement a dynamic TA program for the jurisdictions in the northeast region of the U.S. to implement CBB's mission to improve the performance of the nation's HIV prevention workforce by increasing the knowledge, skills, technology, and infrastructure to implement and sustain science-based, culturally appropriate HIV prevention interventions and strategies.

Role: Co-Principal Investigator

(NIH R01 Grant): Resilience and HIV Risk in Sexual/Gender Minority Victims of Early Life Sex Abuse

Project Narrative: The proposed project is to identify resilience-related factors and behaviors during childhood or adolescence that may reduce HIV risk in sexual and gender minority youth who report having been regularly sexually abused or raped as children/teens. Sadly, very high proportions of sexual and gender minority persons report early life sexual abuse, and this abuse is consistently found to negatively impact HIV risk behaviors during adulthood. Results from our study will be used to develop interventions to enhance or strengthen resilient behaviors during childhood/adolescence in this HIV high risk group, to buffer the negative effects of sexual abuse.

Role: Co-Principal Investigator

(NIH R34 Grant): Adapting an evidence-based HIV prevention intervention for Latinos impacted by the criminal justice system

Project Narrative: The proposed study will provide ways of comprehensively addressing new and unique dimensions of often overlooked sexual risk by substance users through the intersection of lessons learned in HIV research of hard to reach populations, Latino migrant health research, and criminal justice scholarship. If the proposed adaptation is determined to be effective in reducing HIV risk among high-risk Latino(a) substance users, this study will contribute towards filling a void in our current understanding of how to address the needs of a population facing intersecting epidemics.

Role: Co-Principal Investigator

(NIH R34 Grant): A Multicomponent Intervention to Improve HIV Prevention and Care Continua Outcomes among Transgender Women and Men

Project Narrative: The proposed study is highly significant because it targets a vulnerable population and builds upon formative work.
