I teach public health courses in Health Communication at both the undergraduate and graduate levels, undergraduate courses in program planning and evaluation and AIDS and Society, and a graduate level course in Risk Communication.

The Risk Communication Laboratory, located in the Department of Social and Behavioral Sciences in the College of Public Health, is a working research laboratory devoted to implementing risk communication methodologies to develop culturally and developmentally appropriate material to assist in medical decision making. The lab is the only public health research laboratory in the United States using perceptual mapping and psycho-physiological testing methods to study public health issues. As Director I have an active research agenda with active grants from the National Institute of Mental Health, the National Institute of Drug Abuse, the American Cancer Society, Gilead Pharmaceuticals, and Merck Pharmaceuticals, and past support from the National Cancer Institute, the National Institute of Biomedical Imaging and Bio-engineering, the State of Pennsylvania Department of Health, Philadelphia Department of Public Health, tobacco settlement monies through Temple University, and internal funding through Fox Chase Cancer Center and Temple University Hospital. These projects support paid and unpaid PhD research assistants and MPH and BS student interns.

# 3. Associate Professor (Non-Tenure Track) and Undergraduate Program Director, Temple University, Philadelphia, PA (2008-2014)

Responsible for all administrative oversight of the Bachelor of Science Degree in Public Health.
